Freeport-McMoran's lawyers stated that while they believe the plaintiff's theories of liability are unfounded, they decided to make an "early investment" rather than engage in years of litigation.

It should be noted that:

Freeport has been selling off producing properties for several years to "get out" of oil and gas and concentrate on mining.

Time will tell if Freeport-McMoran's decision will affect other defendants.


